#### AGREEMENT

BETWEEN THE GOVERNMENT OF THE PEOPLE'S REPUBLIC OF POLAND AND

THE GOVERNMENT OF THE EMPIRE OF ETHIOPIA

conerning

SCIENTIFIC AND TECHNICAL CO-OPERATION

The Government of the People's Republic of Poland and the Government of the Empire of Ethiopia, desiring to strengthen the friendly relations existing between the two countries.

and desiring to initiate scientific and technical co-operation, have agreed as follows:

#### ARTICLE I

The two contracting Parties shall develop and strengthen Scientific and Eechnical cooperation between the two nations on the basis of the principles of respect for sovereignty, non-interference in each other's domestic affairs and equality, in conformity with the laws in force in the respective countries.

## ARTICLE II

The Parties to this Agreement shall co-operate in the fields of science, technology, planning, public administration and social services.

#### ARTICLE III

The co-operation between the Parties as mentioned under Article I of this Agreement, shall consist of:

- a) exchanges of experts and advisers,
- b) exchange of trainees, students and professors,
- c) granting of scholarships,
- d) undertaking of economic and technical researches and studies,
- e) elaboration of projects and technical documentation required for agricultural and industrial development,
- f) any other form of economic, scientific and technical cooperation, which shall be mutually agreed upon.

#### ARTICLE IV

The terms and conditions of the scientific and technical co-operation set out in Article II of this Agreement shall be agreed upon mutually by authorized bodies of both countries.

The payment of expenses connected with the execution of this Agreement shall be effected according to the provisions to be mutually agreed upon

### ARTICLE V

For the purpose of facilitating the execution of this Agreement the Parties have nominated the Economic and Technical Assistance Board for the Ethiopian Party and the Committee for Economic co-operation with Foreign Countries for the Polish Party and entrusted them with the task of preparing the implementation programmes.

#### ARTICLE VI

Each Government shall extend to the citizens of the other Party sent to its country under the provisions of this Agreement all necessary assitance in accordance with the existing laws and regulations.

#### ARTICLE VII

The two contracting Parties have mutually agreed not to communicate to a third party, without prior consultation with the other Party, the results of the scientific and technical co-operation, when such communication may prejudices the vital interests of the other Party.

# ARTICLE VIII

The present Agreement shall come into force on the date of its signature and shall be valid for a period of three years. It shall be automatically renewable from year to year unless one of the Contracting Parties notifies the other Party three months in advance that it wishes to terminate this Agreement.
